IMPORTANT: Do not expose children, pets or other non-target animals to rodenticides. To help to prevent accidents:

2. Apply bait in locations out of reach of children, pets, domestic animals and non-target wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. USE RESTRICTIONS:

This product may only be used to control the following rodent pests in and around man-made structures: House mouse (*Mus musculus*), Norway rat (*Rattus norvegicus*), Roof rat (*Rattus rattus*), Cotton rats (*Sigmodon hispidus*), Eastern harvest mouse (*Reithrodontomys humuli*), Golden mouse (*Ochrotomys nuttalli*), Polynesian rat (*Rattus exulans*), and Meadow vole (*Microtus pennsylvanicus*). This product must be used in and within 100 feet of man-made structures constructed in a manner so as to be vulnerable to commensal rodent invasions and/or to harboring or attracting rodent infestations. Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles, (ships, trains, aircraft), docks and port or terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting, beyond 100 feet from a structure as defined above, is prohibited. This product must not be applied directly to food or feed crops.

Burrow baiting with Rodex™ Blox™-1 is prohibited.

Do not sell this product in individual containers holding less than four (4) pounds of bait.

SELECTION OF TREATMENT AREAS: Determine areas where rats or house mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain or snow. Remove as much alternative food as possible.

APPLICATION DIRECTIONS: Each Rodex Blox-1 consists of a 16-ounce block scored so that it can be broken into eight 1 oz. pieces.

RATS: Apply 4 to 16 ounces of this product per placement. Space placements at intervals of 15 to 30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there no longer are signs of new feeding by rats.

MICE: Apply ¼ to ½ ounces of bait at each placement location. Space placements at 8- to 12-foot intervals. Larger placements (up to 2 ounces) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there no longer are signs of new feeding by house mice.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Using waterproof gloves collect and dispose of all dead, exposed animals and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in original container in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.
